## ANCHORAGE, ALASKA AR NO. 2009–82

A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY SUPPORTING ACCEPTANCE OF FEDERAL STIMULUS FUNDING AND URGING THE LEGISLATURE TO BUILD CONSENSUS TO CONVINCE THE GOVERNOR TO RECONSIDER REJECTION IN FAVOR OF ACCEPTANCE.

WHEREAS, the American Recovery and Reinvestment Act ("federal stimulus funding") offers federal economic stimulus money to assist local economic recovery, and the Alaska allocation is \$930.7 Million;

WHEREAS, Anchorage schools were slated to get at least \$26 Million for special education and Title One schools, which are in the municipality's poorest neighborhoods; and

WHEREAS federal stimulus funding for education could also be used in Anchorage to expand pre-kindergarten to more low-income children; and

WHEREAS, Governor Palin has announced her intent to reject \$288.1 Million of Alaska's allocation, including approximately \$171 Million in various education programs including special education, technology, "fiscal stabilization" funds, emergency food assistance and school lunch programs, immunizations, infant learning, additional funding for schools with a high proportion of poor students, including the \$26 Million slated for Anchorage programs; and

WHEREAS, Alaska's seasonally adjusted unemployment rate rose to 8% in February 2009, and the Alaska statewide unemployment rate, without seasonal adjustment, is 9.3%; and

WHEREAS, the Municipality of Anchorage and Mat-Su Borough combined unemployment rate, without seasonal adjustment, is 7.9%; and

WHEREAS, despite these alarming economic indicators, Governor Palin is rejecting \$15 Million in unemployment assistance, and stimulus funding for emergency food assistance and homeless grants; and

WHEREAS, Governor Palin is also rejecting \$28 Million for state energy program funding, \$18.5 Million in weatherization program funding, \$8.5 Million in energy conservation program funding, and \$7.2 Million in public safety program funding; and

WHEREAS, the Anchorage School District has avowed full transparency and accountability for the use of all federal stimulus funding allocated to Anchorage; and

WHEREAS, programs initiated and funded by the federal stimulus can be subject to full review for effectiveness after the federal funding cycle;

NOW, THEREFORE, THE ANCHORAGE ASSEMBLY HEREBY RESOLVES:

- 1. The Municipality of Anchorage supports acceptance of federal stimulus funding allocated to Alaska.
- 2. The Alaska Legislature is urged to build consensus to convince the Governor to reconsider rejection in favor of acceptance of federal stimulus funding allocated to Alaska.
