THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That TWENTY THREE THOUSAND FOUR HUNDRED NINETEEN  
DOLLARS (\$23,419) is appropriated from the State of Alaska, Alaska Police Standards Council  
to the State Categorical Grants Fund (231), Anchorage Police Department to purchase classroom  
tables and chairs.


Section 2. That NINE HUNDRED SEVEN DOLLARS (\$907) is appropriated from the  
Anchorage Metropolitan Police Service Area Fund (151), 2009 Anchorage Police Department  
Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police  
Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the  
Anchorage Municipal Assembly.

**Subject:** Appropriation from the State of Alaska, Alaska Police Standards Council (APSC), of classroom table and chairs purchase funding and local match required (\$24,326)

The Municipality of Anchorage has received \$23,419 in funding from APSC to purchase replacement tables and chairs for the Alaska Police Department Training Center classrooms. This grant is intended to initiate phase 1 of a planned multiple classroom rehabilitation project.

This grant will be used to purchase replacement classroom tables and chairs located at the Alaska Police Department Training Center. The department will replace 20 tables and 40 chairs in various stages of disrepair that are utilized in four APD Training Center classrooms. These classrooms are offered for use to many state, local and volunteer agencies for training and presentation purposes.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$907, which has been budgeted in the 2009 Police Operating Budget. This funding is effective from January 1, 2009 to December 31, 2009.
