

Subject: Appropriation from the State of Alaska, Alaska Police Standards Council (APSC), of Special Weapons and Tactics (SWAT) training support funding and local match required (\$5,190)

The Municipality of Anchorage has received \$5,000 in funding from APSC to provide training support to the Anchorage Police Department's SWAT Team.

This grant will be used to purchase operational supplies consumed during SWAT training sessions. The department's SWAT Team provides tactical and classroom training support to numerous statewide law enforcement agencies each year. Specialty teams from other state law enforcement agencies frequently provide highly coordinated incident response which is enabled by this training.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$190, which has been budgeted in the 2009 Police Operating Budget. This funding is effective from January 1, 2009 to December 31, 2009.
