A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING AND CELEBRATING BROWN JUG PASSING ITS 50TH CONSECUTIVE ALCOHOLIC BEVERAGE CONTROL BOARD TEST AND MAKING THE "BROWN JUG MODEL" A NATIONALLY RECOGNIZED BEST PRACTICE.

WHEREAS, underage drinking and irresponsible drinking are serious public health and public safety issues; and

WHEREAS, according to the recent 2009 Report for the Tri-Borough Anti-Gang and Youth Violence Policy Team and Anchorage United for Youth, 75% of Anchorage youth have tried alcohol - with more than one in four binge drinking; and

WHEREAS, on April 29, 2009, Brown Jug employee Chris Mangiapane denied the sale of alcohol to a minor, and in so doing passed the 50th consecutive compliance test by the Alcoholic Beverage Control Board staff at a Brown Jug establishment; and

WHEREAS, Brown Jug, Inc. is the only retailer in Alaska to pass 50 consecutive compliance tests; and

WHEREAS, the Responsible Retailing Forum - a consortium of regulatory, enforcement, and industry representatives coming together to identify Best Practices to prevent underage sale of age-restricted products - has honored Brown Jug, Inc. with its first annual national distinguished retailer award, and created a video explaining how the "Brown Jug Model" works, and efforts are underway to expand the model across the country;
