5 WHEREAS, John (Jack) R. Murdoch began his employment in the water industry
6 with Central Alaska Utilities on November 16, 1976, and on January 1, 1984 began working
7 with the hydrant maintenance and connections crews for the Operations & Maintenance
8 Division of Anchorage Water and Wastewater Utility; and,

10 WHEREAS, on January 7, 1985, Jack transferred from the Operations & Maintenance
11 Division to the Treatment Division, taking a voluntary demotion to learn more about Utility
12 operations; and,

14 WHEREAS, Jack was promoted to Treatment Plant Operator II shortly after his
15 transfer to the Treatment Division, and on February 3, 1988, was promoted to Treatment
16 Plant Senior Operator at the Eklutna Water Treatment Facility. Jack was promoted again to
17 Operations Foreman on October 12, 1995, and to Superintendent on May 20, 2002; and,

19 WHEREAS, Jack has set an example for all employees by continually advancing his
20 skills and those of his colleagues, and by continually improving operation at Anchorage's
21 largest water treatment facility; and,

23 WHEREAS, Jack has served the citizens of Anchorage well by maintaining exemplary
24 standards of performance and leadership in each position held throughout his 32 year career;

27 WHEREAS, Jack will retire from AWWU effective May 28, 2009. He leaves the
28 Utility with a legacy of excellence, and a competent and professional workforce that will
29 guarantee the Municipality of Anchorage is provided with the highest quality water and best in
