THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That ONE HUNDRED THIRTY-NINE THOUSAND FOUR HUNDRED SIXTY-FOUR DOLLARS (\$139,464), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for impaired driving enforcement.

Section 2. That FIVE THOUSAND FORTY-NINE DOLLARS (\$5,049) is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2009 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Appropriation from the State of Alaska, Department of Transportation & Public Facilities, of an Impaired Driving Enforcement Program Grant and local match required (\$144,513)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$139,464 for a DUI .08 Impaired Driving Enforcement program. This grant is intended to support focused enforcement during the period April 1, 2009 through June 30, 2009.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of impaired driving violations within the Municipality of Anchorage. Through increased awareness and enforcement of impaired driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$5,049, which has been budgeted in the 2009 Police Operating Budget. This grant, which is being presented after the actual start date due to late notification from the grantor, began on April 1, 2009 and will end on June 30, 2009.
