A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE HUNDRED SEVENTY-FIVE THOUSAND TWO HUNDRED TWENTY-FOUR DOLLARS (\$175,224) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION & PUBLIC FACILITIES; AND APPROPRIATING SIX THOUSAND THREE HUNDRED FORTY-THREE DOLLARS (\$6,343) AS A CONTRIBUTION FROM THE 2009 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE CATEGORICAL GRANTS FUND (231) ANCHORAGE POLICE DEPARTMENT, SEAT BELT ENFORCEMENT

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That ONE HUNDRED SEVENTY-FIVE THOUSAND TWO HUNDRED TWENTY-FOUR DOLLARS (\$175,224), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for Seat Belt Enforcement.

Section 2. That SIX THOUSAND THREE HUNDRED FORTY-THREE DOLLARS (\$6,343) is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2009 Anchorage Police Department Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

**Subject:** Appropriation from the State of Alaska, Department of Transportation & Public Facilities of a Seat Belt Enforcement Program Grant and local match required (\$181,567)

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$175,224 for a Seat Belt Enforcement program. This grant is intended to support focused enforcement during the period April 1, 2009 through September 30, 2009.

This grant will be used to pay officer overtime for traffic assignments specifically targeted for enforcement of seat belt violations within the Municipality of Anchorage. Through increased awareness and enforcement of seat belt driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$6,343, that has been budgeted in the 2009 Police Operating Budget. This grant, which is being presented after the actual start date due to late notification from the grantor, began on April 1, 2009 and will end on September 30, 2009.
