Section 2. That Eighty Thousand Dollars (\$80,000) is hereby appropriated from the Egan Civic and Convention Center Capital Reserve Account (Fund 401) for facility capital improvements.
Section 3. This resolution shall be effective immediately upon passage and approval by the Assembly.

Management agreements for each of the major municipal facilities provide for a percentage of operating revenues or year-end profits to be deposited in reserve accounts established within Areawide General CIP Fund 401 to: (1) replace equipment that is lost, destroyed, or

otherwise rendered unusable during the normal course of operations; (2) pay the costs for planned future renovations or improvements; or (3) repair damages or losses caused by catastrophic occurrences.

CENTER (EGAN CENTER)

With the upcoming production of "The Lion King", modifications are required within the Atwood Theater for the costumed character's entrance. The south lobby door needs to be modified both in height and width to allow for an oversized character's entrance. Stairways from the main lobby door entrances to the stage also need to be modified to allow even spacing for the costumed characters' parade through the audience. All costs for these modifications will be reimbursed by the production company of "The Lion King."

The Alaska Center for the Performing Arts, Inc has never had any large identifying sign on its building. Recently, approval was given to install a LED identifying sign on the east wall facing Town Square Park. Plans are to have this installed prior to the Labor Day week-end opening of "The Lion King." Costs are to be shared with the Municipality of Anchorage and the Alaska Center for the Performing Arts Board designated funds. Lighting of the sign will only be used during the fall/winter/spring months when the effects will be visible.

Due to the aging of Egan Center, ongoing repairs are needed for improvements, code changes and advances in technology. Currently the revolving doors on the east side of the building are inoperable and need to be replaced. The plan is to change the entrance to replicate the style of doors facing Fifth Avenue. Additionally, a fire inspection report noted required code upgrades to the fire sprinkler system. Lastly, the closed circuit television system used by security needs upgrading. These cameras are necessary to monitor public and employee activity in the Egan Center and have been essentials tools for solving theft issues as well as a vandalism deterrent.

The facility managers, working with the Office of Economic and Community Development and the Maintenance and Operations Department have prepared recommended projects for both the Alaska Center for the Performing Arts Center, Inc and the Egan Center and recommend appropriation of facility capital reserve revenues to complete the projects.
