A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING AND REMEMBERING ALLAN TESCHE FOR HIS PASSIONATE AND DEDICATED SERVICE TO THE COMMUNITY.

WHEREAS, on July 14, 2009, Anchorage lost one of its finest residents with the passing of Allan Tesche, a retired Anchorage attorney and longtime resident, whose life and distinguished career as a public servant are worthy of recognition as an important part of Alaskan history; and

WHEREAS, Allan Tesche served on the Anchorage Assembly from 1999 to 2008 representing the downtown Anchorage, South Addition, Inlet View, Government Hill, Fairview, and Mountain View neighborhoods; and

WHEREAS, as an Assembly Member, Allan Tesche stood up for the rights of immigrants, spoke out for the protection of underage dancers, and rejected a proposal for police to routinely question drivers they pulled over for proof of American citizenship; and

WHEREAS, Allan Tesche's circle of influence reaches far beyond his constituents, to his fellow Assembly Members both past and present, to the local media, to the Anchorage Mayor, and to a United States Senator; and

WHEREAS, it is not only the breadth of Allan Tesche's influence, but the depth of these relationships which will resound throughout history; and

WHEREAS, Senator Mark Begich, who was Anchorage mayor when Allan Tesche served on the Assembly, described Allan Tesche as a close friend, as "one of the most committed and dedicated public servants", and as a man who "gave his heart and soul to his constituents"; and

WHEREAS, recently, friends and constituents have remembered and described Allan Tesche as a thoughtful and relentless advocate who enlisted a tough mind, but also a tender heart; and
