Appropriation of grant and required local matching funds is requested to the Areawide General CIP Fund (401).

Grant funds awarded will provide for the purchase of additional Motorola Project 25 Compatible Interoperable Mobile Radios for the Anchorage Police Department.

FY2008 Reallocated State Homeland Security Program Grant funds will be administered by the Municipal Manager Department, Office of Emergency Management. A special condition of this grant is that the department contribute funds to support associated indirect grant costs. The total projected municipal cost is \$679 which is funded through a contribution from the Anchorage Metropolitan Police Service Area Fund (151).
