In April 2004, voters from the Eagle River-Chugiak Parks and Recreation Service Area approved a new .50 mill rate to generate annual capital funds for parks and recreation. The Assembly approved a 2009 mill rate of .44 on April 28, 2009 that will generate \$1,533,038. These revenues are being collected and deposited into the Eagle River-Chuqiak Parks and Recreation Service Area Fund (162), IGC charges for 2009 amount to \$16,158 leaving a balance of \$1,516,880 to be contributed to the Eagle River-Chugiak Parks and Recreation Service Area Capital Improvement Project Fund (462) for capital maintenance and improvements.

The attached resolution appropriates a \$1,516,880 contribution approved in the 2009 General Operating Budget from the Eagle River-Chugiak Parks and Recreation Service Area Fund (162) to the Eagle River-Chugiak Parks and Recreation Service Area Capital Improvement Project Fund (462).
