A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING TWO MILLION SEVEN HUNDRED THOUSAND THREE HUNDRED THIRTY SEVEN DOLLARS (\$2,700,337) FROM THE U.S. DEPARTMENT OF JUSTICE, OFFICE OF JUSTICE PROGRAMS, AMERICAN RECOVERY AND REINVESTMENT ACT, EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT, AND APPROPRIATING ONE HUNDRED THOUSAND ONE HUNDRED FIFTY FIVE DOLLARS (\$100,155) FROM THE ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151), ANCHORAGE POLICE DEPARTMENT 2009, 2010 AND 2011 OPERATING BUDGETS AS CONTRIBUTIONS TO THE FEDERAL CATEGORICAL GRANTS FUND (241) ANCHORAGE POLICE DEPARTMENT, FOR THE PURPOSE OF UNDERWRITING PROJECTS TO REDUCE CRIME AND IMPROVE PUBLIC SAFETY.

THE ANCHORAGE ASSEMBLY RESOLVES:

That the sum of TWO MILLION SEVEN HUNDRED THOUSAND THREE Section 1. HUNDRED THIRTY SEVEN DOLLARS (\$2,700,337), is appropriated from the U.S. Department of Justice, Office of Justice Programs, American Recovery and Reinvestment Act, Edward Byrne Memorial Justice Assistance Grant to the Federal Categorical Grants Fund (241), Anchorage Police Department for the purpose of underwriting projects to reduce crime and improve public safety.

That the sum of ONE HUNDRED THOUSAND ONE HUNDRED FIFTY FIVE DOLLARS (\$100,155) is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2009, 2010 and 2011 Anchorage Police Department Operating Budget as contributions to the Federal Categorical Grants Fund (241), Anchorage Police Department for the purpose of underwriting projects to reduce crime and improve public safety.

Edward Byrne Memorial Justice Assistance Grants, authorized by the Crime Identification Technology Act, 1998 (42USC14601), provide local governments with funds to underwrite projects to prevent and control crime based on local needs and conditions. The Municipality of Anchorage has been awarded an American Recovery and Reinvestment Act grant in the amount of \$2,700,337 with a required local contribution of \$100,155 for a total program budget of \$2,800,492. The local contribution will be appropriated in equal amounts of \$33,385 for budget years 2009, 2010 and 2011. These amounts are requested to be appropriated to the Federal Categorical Grants Fund (241) for use by the Anchorage Police Department. This grant began on March 1, 2009 and will end on February 28, 2013.
