Appropriation from the U.S. Department of Justice, Community Oriented

Policing Services for a COPS Hiring Recovery Program Grant Award

(\$2,722,361)

The U.S. Department of Justice, Office of Community Oriented Policing Services has provided funding under the FY2009 American Recovery and Reinvestment Act, COPS Hiring Recovery Program. The Municipality of Anchorage has been awarded a grant in the amount of \$2,599,578 to retain nine sworn officer positions that otherwise would be laid off. This grant is intended to provide entry level sworn officers salary for a three year period during the period July 1, 2009 through June 30, 2012.

A special condition of this grant is that the department fully funds these nine sworn officer positions for a fourth retention year and provides a local contribution of \$122,783. The local contribution will be appropriated as follows:

- \$17,948 2009 Police Operating Budget
- \$39,406 2010 Police Operating Budget
- \$43,403 2011 Police Operating Budget
- \$22,026 2012 Police Operating Budget

This program grant is being presented for appropriation after the start of the actual performance period due to a delay in grant award from the U.S. Department of Justice. This grant began on July 1, 2009 and will end on June 30, 2012.
