11 Section 1. That FOUR THOUSAND SIX HUNDRED TWENTY FIVE DOLLARS (\$4,625)
12 is appropriated from the State of Alaska, Alaska Police Standards Council to the State
13 Categorical Grants Fund (231), Anchorage Police Department to provide armorer training.

15 Section 2. That ONE HUNDRED NINETY THREE DOLLARS (\$193) is appropriated from
16 the Anchorage Metropolitan Police Service Area Fund (151), 2009 Anchorage Police Department
17 Operating Budget as a contribution to the State Categorical Grants Fund (231), Anchorage Police
18 Department.

Subject: Appropriation from the State of Alaska, Alaska Police Standards Council (APSC), of Armorer Training funding and local match required (\$4,818)

The Municipality of Anchorage has received \$4,625 in funding from APSC to provide Basic and Advanced Armorer Training for the Anchorage Police Department. This grant will allow 10 sworn officers to attend armorer training and maintain certification.

This grant will be used to provide basic and advanced AR-15 Weapon Armorer Courses for up to ten sworn officers who will maintain certification for three years from the training date. These officers will be available on various shifts to perform armorer level repairs and maintenance to field deployed patrol rifles.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$193, which has been budgeted in the 2009 Police Operating Budget. This funding is effective from January 1, 2009 to December 31, 2010.
