The period of this grant is from July 1, 2009 through 11 12 June 30, 2010. 13 The Department of Health and Human Services operates the Child Care Licensing Program 14 which has been responsible for licensing child care centers since 1988. On September 23, 15 2004 the role of the unit was expanded to full child care home licensing responsibility. The 16 17 department is fully responsible for issuing licenses and enforcement. Previously, the program only recommended licensure for family child care homes to the State which made 18 final enforcement decisions and issued licenses. 19 20 In the previous year, the Municipal Child Care Licensing Program served 114 licensed 21 child care centers, which offer Anchorage approximately 7,900 spaces for child care and 22 opened 6 new centers. In serving child care homes, 174 were assisted with approximately 23 1,300 spaces for child care.
