**A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING AND

WHEREAS, the State of Alaska has appropriated Twenty-One Million Dollars (\$21,000,000) to the Municipality of Anchorage as capital grants per AS 37.05.315 for general government and Port of Anchorage; and

WHEREAS, the Administration and the Assembly have reviewed the grants offered by the State of Alaska; and

WHEREAS, a duly advertised public hearing was held in accordance with Section 6.10.085 of the Municipal Code; now therefore,

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. State legislative grants in the amount of Twenty-One Million Dollars (\$21,000,000) are hereby accepted and appropriated.

Section 2. That the amounts set forth below shall be and hereby are supplemental appropriations for the respective funds for the 2009 fiscal year.
