The accompanying resolution appropriates Forty-Four Thousand Dollars (\$44,000) from revenue that was recently received by the Real Estate Services Division (RES) of Heritage Land Bank from the sale of a parcel in Anchorage. This land sale was an unanticipated and unbudgeted transaction in which RES was recipient of revenues totaling approximately Fifty-Five Thousand Five Hundred Dollars (\$55,500).

RES is also the recipient of a three-year EPA Brownfields Cleanup Grant that begins in 2009. The EPA grant provides Two Hundred Thousand Dollars (\$200,000) and requires twenty percent, or Forty Thousand Dollars (\$40,000), in cost share support from the recipient. Per the terms of the grant, the recipient is also responsible for administrative costs, totaling Four Thousand Dollars (\$4,000).

The purpose of this resolution is to revise the RES 2009 Operating Budget to allow for acquisition of the needed portion of this sale revenue to fund RES's share of support for this grant.

A concurrent Assembly Resolution shall then appropriate the necessary monies to provide timely support for work to begin on behalf of the cleanup grant, which is more fully described in its accompanying Assembly Memorandum.
