THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That ONE HUNDRED FORTY-TWO THOUSAND SEVEN HUNDRED TWENTY-FIVE DOLLARS (\$142,725), is appropriated from the State of Alaska, Department of Transportation & Public Facilities to the State Categorical Grants Fund (231), Anchorage Police Department, for impaired driving enforcement.

The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities, in the amount of \$142,725 for a DUI .08 Impaired Driving Enforcement program. This grant is intended to support focused enforcement during the period October 1, 2009 through December 31, 2009.

This grant will be used to pay officer overtime and benefits for focused traffic assignments specifically targeted for enforcement of impaired driving violations within the Municipality of Anchorage. Through increased awareness and enforcement of impaired driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$6,098, which has been budgeted in the 2009 Police Operating Budget. This grant, which is being presented after the actual start date due to late notification from the grantor, began on October 1, 2009 and will end on December 31, 2009.
