On October 13, 2009, AR 2009-239 was approved by the Municipal Assembly appropriating One Million Four Hundred Thirty-eight Thousand Dollars (\$1,438,000). The Department of Health and Human Services received One Hundred Thousand Dollars (\$100,000) more in supplemental funds from the Alaska Department of Health and Social Services bringing the total grant amount to One Million Five Hundred Thirty-eight Thousand Dollars (\$1,538,000). The period of the grant is from July 1, 2009 to June 30, 2010.

Under the terms of the grant, the Municipal Department of Health and Human Services will provide the following services:

- Direct surveillance and response to natural or intentional public health threats and emergencies including current influenza threats, day-to-day disease surveillance, investigation and outbreak response activities;
- Plan and implement pandemic flu, infectious disease outbreak and bioterrorism preparedness and response measures;
- Enhance the ongoing MOA capacity to respond to a pandemic flu outbreak;
- Develop a plan for emergency mobilization of existing pharmaceutical reserves in Anchorage and, as needed, assist in the receipt and distribution of the Strategic National Pharmaceutical Stockpile;
- Serve as the MOA public health representative on local and state bioterrorism planning, exercise and response efforts;
  - Facilitate efforts of local public health staff to advise and assist in working with community leaders, the Local Emergency Planning Committee, and other local health and safety agency partners;

- Conduct training needs assessment(s), develop and implement training and marketing plans, and coordinate training of DHHS staff related to public health preparedness and response to bioterrorism, infectious disease, and other public health threats and emergencies;
   Promote participation by local health care providers in various trainings offered
  - Promote participation by local health care providers in various trainings offered through the Alaska Public Health Training Network;
  - Coordinate with the State Division of Public Health to assess the communication needs in the Municipality of Anchorage related to bioterrorism, infectious disease and other public health threats and emergencies; and
  - Develop a communication plan and strategies, and produce communication messages for residents and special population groups in the Municipality of Anchorage.
