**A RESOLUTION APPROPRIATING A GRANT IN THE AMOUNT OF EIGHTY THOUSAND DOLLARS (\$80,000) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION, ALASKA HIGHWAY SAFETY OFFICE, FOR A TRAFFIC SAFETY RESOURCE PROSECUTOR.**

**WHEREAS**, the State of Alaska offered the Department of Law a grant for administration of the State of Alaska, Department of Transportation, Alaska Highway Safety Office (SOA DOT AHSO) Program; and

**WHEREAS**, the Department of Law agrees to administer the SOA DOT AHSO Program to meet the goals of both state and local interests, provided State funding is available; now therefore,

**THE ANCHORAGE ASSEMBLY RESOLVES:**

**Section 1.** The sum of EIGHTY THOUSAND DOLLARS (\$80,000) is hereby appropriated from the State of Alaska, Department of Transportation, to State Categorical Grants Fund (231) for administration SOA DOT AHSO Program in the Department of Law.

**Section 2.** This resolution shall be effective immediately upon its passage and approval by the Assembly.

3 **Subject: A RESOLUTION APPROPRIATING A GRANT IN THE AMOUNT OF**  
4 **EIGHTY THOUSAND DOLLARS (\$80,000) FROM THE STATE OF**  
5 **ALASKA, DEPARTMENT OF TRANSPORTATION, ALASKA**  
6 **HIGHWAY SAFETY OFFICE, FOR A TRAFFIC SAFETY RESOURCE**  
7 **PROSECUTOR.**

9 The Department of Law is approved to administer a grant for a Traffic Safety  
10 Resource Prosecutor; the grant partially offsets the cost of the position. This  
11 resolution appropriates the 2009 grant from State of Alaska, Department of  
12 Transportation, Alaska Highway Safety Office (SOA DOT AHSO) to fund the  
13 program.  
14

15 The position entails a part-time Municipal Traffic Safety Resource Prosecutor  
16 (TSRP) funded by the grant, and a part-time DUI/Traffic Prosecutor funded by  
17 the city. The city will take an existing prosecutor position and split its time to  
18 accommodate the requirements of the grant.  
19

20 The TSRP serves as the dedicated liaison among prosecutors, the police  
21 department, State District Attorneys, AHSO, Alaska Injury Prevention Center,  
22 public and private schools and defense attorneys to provide information and  
23 education to the motoring public to prevent impaired driving and reduce OUI  
24 collisions and fatalities.  
25

26 The position requires training to educate all prosecutors and police officers in  
27 testing relating to drug recognition evaluation, field sobriety tests, and trial  
28 preparation. The TSRP also assists prosecutors with applying for scholarships  
29 and grants for national training opportunities as well as creating a DUI trial  
30 manual. In addition, the TSRP will second-chair difficult DUI trials assist in  
31 other safety cases and serve as a resource to evaluate DUI cases for  
32 reduction or dismissal.
