The attached Assembly Resolution requests appropriation of Seventy-six Thousand Four Hundred Forty-six Dollars (\$76,446) from the Areawide General Fund Balance (101) to the Real Estate Services Division's 2009 Operating Budget Fund (101) to make December payments for building space currently leased by MOA.

The request is based on contractual increases tied to changes in the Consumer Price Index (CPI), which were higher than originally estimated. This increase was anticipated early 2009 and a first quarter budget request was submitted; however, the administration chose not to forward the request to the Assembly for action.

The total shortfall is \$112,446, but the department is able to reallocate \$36,000 towards this amount, with \$76,446 remaining due.
