## ANCHORAGE, ALASKA AR NO. 2009-296

A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING SIXTEEN THOUSAND SIX HUNDRED EIGHTY-FIVE DOLLARS (\$16,685) AS A GRANT FROM THE STATE OF ALASKA, DEPARTMENT OF MILITARY AND VETERANS AFFAIRS, DIVISION OF HOMELAND SECURITY AND EMERGENCY MANAGEMENT AND APPROPRIATING SEVEN HUNDRED TEN DOLLARS (\$710) AS A CONTRIBUTION FROM THE 2009 ANCHORAGE POLICE OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE CATEGORICAL GRANTS FUND (231), ANCHORAGE POLICE DEPARTMENT, FOR THE PURCHASE OF TERRORISM RESPONSE AND PREVENTION EQUIPMENT.

## THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of SIXTEEN THOUSAND SIX HUNDRED EIGHTY-FIVE DOLLARS (\$16,685) is appropriated as a grant from the State of Alaska, Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management to the State Categorical Grants Fund (231), Anchorage Police Department, for the purchase of terrorism response and prevention equipment.

Section 2. That the sum of SEVEN HUNDRED TEN DOLLARS (\$710) is appropriated from the 2009 Anchorage Police Operating Budget, Anchorage Metropolitan Police Service Area Fund (151) as a contribution to the State Categorical Grants Fund (231), Anchorage Police Department, for the purchase of terrorism response and prevention equipment.

<u>Section 3.</u> This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

Appropriation of State of Alaska, Department of Military and Veterans Affairs, Division of Homeland Security and Emergency Management State Homeland Security Reallocated FY2007 Law Enforcement Terrorism Prevention Program Grant Funding (\$17,395)

The Municipality of Anchorage, Anchorage Police Department has received from the Office for Domestic Preparedness through the State of Alaska, FY2007 Reallocated LETPP Grant funding to enhance security and preparedness for terrorist prevention. Appropriation of grant and required local matching funds is requested to the State Categorical Grants Fund (231).

Grant funds awarded provide for the procurement of additional specialized terrorism incident response equipment to be utilized by the Anchorage Police Department.

FY2007 Reallocated Law Enforcement Terrorism Prevention Program Grant funds will be administered by the Anchorage Police Department. A special condition of this grant is that the department contribute funds to support associated indirect grant costs. The total projected municipal cost is \$710 which is funded through a 2009 operating contribution from the Anchorage Metropolitan Police Service Area Fund (151). This grant began on October 1, 2007 and will end on January 31, 2010.
