The attached Resolution appropriates one hundred thousand dollar (\$100,000) contribution from the Anchorage Bowl Parks and Recreation Service Area Fund (161) approved in the 2009 General Operating Budget to the Anchorage Bowl Parks and Recreation Service Area Capital Fund (461) to establish a capital reserve fund for future pool repairs at Bartlett Pool, Dimond Pool, East Pool, Service Pool and West Pool.

Proposition 4, Anchorage Bowl Parks and Recreation Service Area Pool Improvement Bonds approved by the voters in the April 2008 general election, included a provision to establish a reserve fund intended for future pool repairs to five municipal pools: Bartlett Pool, Dimond Pool, East Pool, Service Pool and West Pool. The annual operating and maintenance costs in the amount of \$223,000 for the Anchorage Bowl Parks and Recreation Service Area Pool Improvement Bonds included an amount up to \$100,000 for the reserve fund. The first annual installment of the capital reserve contribution has been established in the Approved 2009 General Operating Budget and is ready for appropriation to the capital fund.
