1 AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY
2 GEOGRAPHICALLY EXPANDING ASSESSMENT DISTRICT 1SD97, ALSO KNOWN
3 AS THE DOWNTOWN IMPROVEMENT DISTRICT, AS A SPECIAL ASSESSMENT
4 DISTRICT FOR SERVICES WITHIN THE AREA OF DOWNTOWN ANCHORAGE
5 ESTABLISHED BY ANCHORAGE ORDINANCE 97-51 TO INCLUDE ADDITIONAL
6 PROPERTIES TO THE WEST AS MORE SPECIFICALLY SHOWN ON THE
7 ATTACHED MAP OF THE REVISED SPECIAL ASSESSMENT DISTRICT 1SD97;
8 AUTHORIZING THE DISTRICT, AS EXPANDED, TO CONTINUE TO PROVIDE
9 PUBLIC IMPROVEMENT SERVICES; ESTABLISHING THE BASIS AND METHOD
10 OF ASSESSING, ALLOCATING AND APPORTIONING THE COSTS OF SERVICES,
11 AND THE RULES AND PROCEDURES FOR ASSESSMENT CALCULATIONS,
12 BILLINGS, PENALTIES, INTEREST, COSTS, APPLICATION OF PAYMENTS AND
13 ENFORCEMENT OF ASSESSMENTS; AND OTHER RELATED PROVISIONS.

14
15 THE ANCHORAGE ASSEMBLY MAKES THE FOLLOWING FINDINGS,
16 DETERMINATIONS, AND CONCLUSIONS:

18 WHEREAS, by Anchorage Ordinance 96-77(S-1) Am., and Anchorage
19 Ordinance 96-112, in accordance with Anchorage Municipal Charter, Article IX, Section
20 9.02, the Anchorage Assembly provided for the creation of assessment districts for
21 public services; and

23 WHEREAS, by Anchorage Ordinance 97-51, the Downtown Improvement District
24 1SD97 (Assessment District 1SD97) was established, as requested by petition of the
25 property owners and as corrected by the Revisor of Ordinances in AM 80-98; and

27 WHEREAS, a property owner petition for the continuation of special services in
28 Assessment District 1SD97, was duly filed with the Municipal Clerk on May 2, 2000; and

30 WHEREAS, by Anchorage Ordinance 2000-98, the Downtown Improvement
31 District 1SD97 (Assessment District 1SD97) was continued, with a petition process
32 called for in 2010; and

34 WHEREAS, property owner petition statements for the expansion and
35 continuation of Assessment District 1SD97, were duly filed with the Municipal Clerk on
36 the 9th day of July, 2010 and thereafter as received; and

38 WHEREAS, in compliance with Anchorage Municipal Code (AMC) 19.20.030 and
39 AMC chapter 1.15, the Municipal Manager has made a report on said property owner

1 petitions to the Municipal Assembly with a recommendation that the Assembly approve
2 the continuation and expansion of this Downtown Improvement District 1SD97, as per
3 said property owner petitions; and

4
5 **WHEREAS**, the Assembly has duly noticed and held a public hearing on the
6 advisability of the continuation and expansion of Assessment District 1SD97 and has
7 duly considered and evaluated the evidence and testimony received, including the
8 petition statements, the Municipal Manager's report and other evidence and information,
9 on the aggregate basis of which the Assembly has made the findings, determinations
10 and conclusions contained in these recitations; and

11
12 **WHEREAS**, the property owners who would bear more than fifty-percent (50%)
13 of the estimated cost of the service have petitioned for and approved the continuation
14 and expansion of Assessment District 1SD97, for assessment within the revised
15 Assessment District 1SD97 Map appended to and incorporated herein as a part of this
16 ordinance (the "Map"); and

17
18 **WHEREAS**, the purpose of the continuation and expansion of Assessment
19 District 1SD97 is to provide and finance public services authorized for service
20 assessment districts under Anchorage Municipal Charter Section 9.02 and AMC
21 section 19.10.020 A.2., which are either not generally provided or provided at different
22 levels by the Municipality; and

23
24 **WHEREAS**, Assembly finds the public services are necessary, of benefit to the
25 properties to be assessed, and the petitions for the public services have been approved
26 by sufficient and proper petitioners; and

27
28 **WHEREAS**, neither the proposed services nor Assessment District 1SD97 itself
29 will operate unilaterally or by implication as a substitute for or to reduce or eliminate the
30 nature and extent of services otherwise generally provided by the Municipality now or in
31 the future; and

32
33 **WHEREAS**, the revised area within which the proposed services for Assessment
34 District 1SD97 are to be furnished conforms to the zoning district requirements of AMC
35 19.10.020 A.2.; and

36
37 **WHEREAS**, the annual, aggregate assessable costs of the services to be
38 provided by Assessment District 1SD97 are set out in this ordinance as annual
39 assessments based on the annual assessment roll, utilizing the proposed cost
40 allocation formula with an assessment cap; and

41
42 **WHEREAS**, the petition process utilized by the property owners is in compliance
43 with AMC chapter 19.20; now therefore,

1 **THE ANCHORAGE ASSEMBLY ORDAINS:**

2
3 **Section 1.** Subject to the provisions of this ordinance, Assessment District 1SD97,
4 also known as the Downtown Improvement District, an assessment district for services
5 within the Municipality duly created under Municipal Charter and Code, is hereby
6 continued and expanded as set forth herein.
7

8 **Section 2.** The Municipality shall proceed with the furnishing of authorized public
9 services within Assessment District 1SD97, in accordance with AMC title 19 and this
10 ordinance.
11

12 **Section 3.** Assessment District 1SD97 shall be comprised of the property within the
13 geographical area outlined on the attached Map, incorporated herein by this reference.
14

15 **Section 4.** The properties are defined by legal description as recorded in the latest
16 municipal tax roll and set out in the attachment, incorporated herein.
17

18 **Section 5.** The public services provided within Assessment District 1SD97 are
19 authorized by this ordinance in accordance with AMC section 19.10.020 A.2., including
20 amendment thereof, provided however, pursuant to AMC 10.10.020 B. and C., such
21 public services shall only be enhanced or supplemental public services, or new public
22 services not generally provided by the Municipality, and said services shall not operate
23 unilaterally or by implication as a substitute for or to reduce or eliminate the nature or
24 extent of services otherwise provided by the Municipality now or in the future. Subject
25 to the conditions of this ordinance, Assessment District 1SD97's presently authorized
26 public services include:
27

- 28 A. Maintenance, repair and upkeep of public capital improvements located in
29 the area of the assessment district;
- 30 B. Maintenance, snow removal, dust suppression, cleaning, beautification,
31 and decoration of public parks, places and pedestrian rights-of-way;
- 32 C. Visitor and tourism services;
- 33 D. Security services, but not including law enforcement services;
- 34 E. Promotion of the assessment district and the promotion of public events
35 within the assessment district; and
- 36 F. Other closely similar public services promoting the vitality, stability and
37 improvement of the assessment district.

38
39 **Section 6.** The annual, aggregate assessable cost of services provided in
40 Assessment District 1SD97 per year shall be assessed annually against assessable
41 property within the geographical boundaries of Assessment District 1SD97, based on
42 the assessed valuation thereof as follows:
43

44 Each assessable parcel within the Assessment District 1SD97 shall be assessed
45 at a mill rate not to exceed 1.5 mills of assessed value (\$1.50 per \$1,000 of

assessed value) up to and including \$10,000,000 plus \$100 per \$1,000,000 of assessed value in excess of \$10,000,000;

provided, however, that at the end of every fifth (5th) calendar year, beginning with year 2015, the assessment formula and/or the assessment mill rate shall be reviewed and may be revised or amended upon approval of property owners bearing more than fifty percent (50%) of the estimated assessable costs of the services.

Section 7. In 2020, during the 10th calendar year after passage of this ordinance, property owners within the Assessment District area shall be petitioned with the options of terminating, continuing, or modifying Assessment District 1SD97, with a report of the results of said petition presented to the Assembly for action, pursuant to AMC chapter 19.20.

Section 8. Property within the geographical area of Assessment District 1SD97 owned by governments, churches, non-profit religious, charitable or educational organizations which are exempt from property taxes shall also be exempt from Assessment District 1SD97 assessments. In addition, the qualified owners of single-family, owner-occupied residences, who timely apply for exemption from Assessment District 1SD97 shall be exempt from such assessment.

Section 9. As provided by AMC 1920.050, an account shall be kept of all costs of the improvement and service.

Section 10. The Assessment Roll for assessing the cost of the services provided to the properties in Assessment District 1SD97:

- A. Shall be prepared in accordance with AMC title 19, this ordinance and any amendments thereof.
- B. Shall include and establish the aggregate, annual assessment to be levied against each assessable parcel of property each calendar year based on the annual assessed valuation.
- C. AMC section 19.20.240 notwithstanding, annual assessments in Assessment District 1SD97 shall be due and payable on, and delinquent after, a date each year commencing in the year 2011 2010, provided however no payment shall be required before sixty (60) days after Assembly confirmation of the Assessment Roll.
- D. Contrary provisions of AMC title 19 notwithstanding, penalties, interest, costs, application of payments and enforcement of these assessments shall be the same as provided for real property taxes in AMC chapter 12.15.
- E. AMC sections 19.20.240, 19.20.260, 19.20.265, and 19.20.280, shall not apply to Assessment District 1SD97.


Section 11. This Ordinance and/or such other documents as may be necessary and

1 appropriate, shall be recorded in the Office of the Recorder for the Anchorage
2 Recording District, Third Judicial District, State of Alaska, and shall be sufficient to
3 create a lien on property assessed in favor of the Municipality to secure the payment of
4 the assessment.

5
6 **Section 12.** Except as modified herein, provisions of AO 97-51 and AO 2000-98 shall
7 remain in effect as applicable to the Downtown Improvement District.

8
9 **Section 13.** This ordinance shall become effective immediately upon its passage and
10 approval by the Assembly.

7 ANCHORAGE ESTABLISHED BY ANCHORAGE ORDINANCE 97-51 TO INCLUDE
8 ADDITIONAL PROPERTIES TO THE WEST AS MORE SPECIFICALLY SHOWN ON
9 THE ATTACHED MAP OF THE REVISED SPECIAL ASSESSMENT DISTRICT 1SD97;
10 AUTHORIZING THE DISTRICT, AS EXPANDED, TO CONTINUE TO PROVIDE PUBLIC
11 IMPROVEMENT SERVICES; ESTABLISHING THE BASIS AND METHOD OF
12 ASSESSING, ALLOCATING AND APPORTIONING THE COSTS OF SERVICES, AND
13 THE RULES AND PROCEDURES FOR ASSESSMENT CALCULATIONS, BILLINGS,
14 PENALTIES, INTEREST, COSTS, APPLICATION OF PAYMENTS AND ENFORCEMENT
15 OF ASSESSMENTS; AND OTHER RELATED PROVISIONS.
16

17 Submitted is an ordinance authorizing the continuation and expansion of Assessment
18 District 1SD97, the Downtown Improvement District (DID). The Downtown Improvement
19 District was created in 1997, initiated by property owner petition, and is presented to the
20 Assembly for authorization as required by law.
21

22 Property owner petition statements for the geographic expansion and continuation of public
23 services for the Downtown Improvement District were filed with the Municipal Clerk. As of
24 August 20, 2010, petition statements signed in favor of expanding and continuing the
25 Downtown Improvement District represent 316 properties and 61.7498% of the estimated
26 annual cost of the service assessment. Petitions in favor of expanding and continuing the
27 Downtown Improvement District exceed the requirement in AMC 19.20.020 which specifies
28 that owners of properties which will bear more than 50 percent of the estimated assessed
29 cost of the improvement or service must petition in favor of the Downtown Improvement
30 District.
31

32 The petition statements support expansion of the Downtown Improvement District to
33 include additional property to the west as more specifically shown on the attached map,
34 and to continue to provide public improvement services that are in addition to regular
35 Municipal services, within the Downtown Improvement District as expanded. These
36 services will not reduce or eliminate services otherwise provided by the Municipality.
37

38 Examples of services currently provided in the Downtown Improvement District include:
39

- 40 • Uniformed downtown "ambassadors" trained to provide informational services and
41 provide safety and security assistance (not including law enforcement) to residents,
42 businesses, visitors, and downtown employees.

- Uniformed cleaning crews to assure cleaned sidewalks, gutters, and alleys. This includes power-cleaning sidewalks during the summer months and clearing alley entrances and crosswalks in winter.
- Graffiti removal in coordination with the Municipality of Anchorage.
- Coordination with existing law enforcement and community service organizations.
- Active promotion of downtown to residents, visitors, and downtown employees.
- Assist, coordinate and plan public events within the DID boundaries.

Downtown Improvement District assessments fund the public services provided by the DID. Additional funds can be made available by the Anchorage Downtown Partnership and its affiliates to supplement the DID assessments and services. These additional funds can be received in the form of donations and grants as well as dues paid by the members of the Anchorage Downtown Partnership, LLC.

Under AO 2010-58, assessments are calculated upon the basis of real property tax valuation. Real property will be assessed at the rate of 1.5 mills of the real property tax valuation up to and including \$10,000,000, plus \$100 per \$1,000,000 of assessed value in excess of \$10,000,000, as approved by property owner petition.

Property within the DID owned by organizations which are exempt from property taxes, such as government, religious, charitable, or educational organizations, shall be exempt from the DID assessments. In addition, the owners of qualified, owner-occupied, single-family residences who have applied for exemption from the DID will not be assessed. Exempt properties do not increase the assessment rate for non-exempt properties because the assessment rate per property is a fixed rate to non-exempt properties.

The ordinance provides that at the end of every fifth year, beginning with year 2015, the assessment formula and/or assessment mill rate shall be reviewed and may be revised or amended upon approval of property owners bearing more than fifty percent (50%) of the estimated cost of the annual assessment. It also provides that in 2020, during the 10th calendar year after passage of the ordinance, property owners within the assessment district shall be petitioned with the options of terminating, continuing or modifying the Downtown Improvement District.

7 This AIM recommends the Assembly proceed with the continuation and expansion of
8 Special Assessment District 1SD97, the Downtown Improvement District. The
9 Downtown Improvement District was created in 1997, initiated by property owner
10 petition, and is presented to the Assembly for authorization as required by law.

11
12 Property owner petition statements for the geographic expansion and continuation of
13 public services for the Downtown Improvement District were filed with the Municipal
14 Clerk.

15
16 As of August 25, 2010, petition statements signed in favor of expanding and continuing
17 the Downtown Improvement District represent approximately 61% of the owners of
18 properties that will bear the estimated annual cost of the service assessment. Petitions
19 in favor of expanding and continuing the Downtown Improvement District exceed the
20 requirement in Anchorage Municipal Code section 19.20.020, specifying that owners of
21 properties bearing more than 50 percent of the estimated assessed cost of the
22 improvement or service must sign the petitions in favor of the Downtown Improvement
23 District. The vote detail was reviewed and verified by the Office of Management and
24 Budget and the Property Appraisal Division. The boundaries of the area and the
25 specific properties benefitted are identified in attachments to AO 2010-58 (S) and
26 AM 457-2010.

27
28 The services that may be provided include:

- 29
30 • Maintenance, repair and upkeep of public capital improvements located in
31 the areas of the assessment district;
- 32
33 • Maintenance, snow removal, dust suppression, cleaning, beautification, and
34 decoration of public parks, places and pedestrian and vehicular rights-of-
35 way;
- 36 • Visitor and tourism services;
- 37
38 • Security services, but not including law enforcement services;

- Promotion of the assessment district and public events within the district; and
 - Other closely similar public services which promote the vitality, stability and improvement of the assessment district.

The assessment rate is 1.5 mills up to and including \$10,000,000 plus \$100 per \$1,000,000 of assessed value in excess of \$10,000,000. The total assessment of all properties is estimated to be \$1,062,264, using 2010 assessed values. The 2011 total assessments of all properties will be updated in 2011.

This letter responds to your request for an advisory opinion regarding a potential conflict of interest related to the Downtown Business Improvement District. In issuing this opinion, the Board of Ethics relied on the information presented to us in your letter of April 9, 2010, and additional information provided by Deputy Municipal Attorney, Rhonda Westover, at the Board meeting held April 16, 2010. The Board did not undertake an independent investigation of the information. If material facts were not disclosed or were misrepresented, this opinion is without force and effect.

As the Board understands it, you are the part-owner of a business in the Downtown Business Improvement District (BID). Currently a petition is being circulated that would continue, dissolve and/or expand the boundaries of the BID. When presented as petition, the Mayor must report the petition to the Assembly with a description, analysis and recommendation on proposed changes to the BID. Such changes would likely affect your downtown business.

The Ethics Code states as follows:

The potential for conflict of interest presented by a financial or private interest held by the mayor shall be disclosed prior to action to the ethics board for determination and management of the potential for conflict of interest under the factors of 1.15.025 B.1.

See AMC 1.15.025 B.3. The Board finds you complied with this provision by disclosing to the Board your potential conflict in this matter, prior to any action being taken by your office related to the petition.

The Board also considered the factors of AMC 1.15.025 B.1 and determined that if the circulating BID petition requires action on the part of the Mayor, then your financial interest in business in the Downtown BID creates a conflict of interest. In order to

"maintain the integrity of the decision making process" (I.I5.025.B.1.e) the Board recommends:

- 1) That you designate the Municipal Manager as your "point person" on this matter.
- 2) That you avoid participating in, or even being present at, any administrative discussion or decision making regarding this matter.
- 3) That any report to the Assembly regarding this petition be made by the Municipal Manager or the head of the department that prepares the report.
- 4) That any report to the Assembly regarding this petition include a statement detailing your conflict of interest, the steps you have taken to manage it, and this advisory opinion.
- 5) That any legislative action on the part of the Assembly regarding this petition be introduced by a member of the Assembly and not as a request from the Mayor's office.
