The 2009 Homeland Security Grant Program grant will enable the Municipality of Anchorage to link local volunteer safety and emergency programs more effectively with the national Citizen Corps initiatives to provide a comprehensive emergency preparedness program for the community.

State Homeland Security Program Grant funds will be administered by the Municipality of Anchorage, Office of Emergency Management.

Grant performance period is October 1, 2009 through December 31, 2011.
