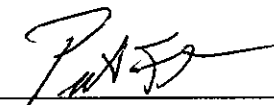

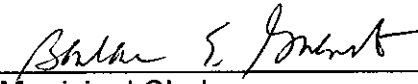
10 **Section 1.** The sum of Five Thousand Dollars (\$5,000) is hereby appropriated
