A total contribution of \$100,155 is required to fund Central Services Charges related to administering the grant. Typically, this is fully funded when appropriation of the grant is initially made. Since this grant and the associated costs were unexpected, and the Anchorage Police Department was uncertain it had the total contribution amount available in 2009, the contribution was split over three years: \$33,385 in 2009, 2010 and 2011. At this point, \$66,770 is required to fund the balance of the Central Services Charges still assessed to the grant.
