6 WHEREAS, Alaska Native Sisterhood Grand President, *Elizabeth Peratrovich*, worked
7 tirelessly to overcome the prejudice and discrimination toward Alaska Natives; and

9 WHEREAS, *Elizabeth Peratrovich* was appalled by open discrimination against Natives by
10 Alaska business establishments; and

11
12 WHEREAS, when the bill to outlaw discriminatory practices was introduced, *Elizabeth*
13 *Peratrovich* organized five Native women to lobby for the law to be passed; and

14
15 WHEREAS, at the Legislative debate, *Elizabeth Peratrovich* asked and was granted the
16 opportunity to speak to the Legislature and made a moving and highly dramatic presentation,
17 which was a major turnaround for some senators; and

18
19 WHEREAS, the bill passed the Senate 11-5, and Governor Gruening signed the measure on
20 February 16, 1945; and



23 *Elizabeth Peratrovich*.

25 NOW, THEREFORE, the Anchorage Municipal Assembly resolves:


