Subject: A resolution of the Municipality of Anchorage appropriating Four Hundred Ninety Seven Thousand Six Hundred Fifty Dollars (\$497,650) in hazardous fuels mitigation funding as a pass-thru grant from the State of Alaska, Department of Natural Resources, under the 2009 American Recovery and

Department of Natural Resources, under the 2009 American Recovery and Reinvestment Act, to the Anchorage Fire Department, State Categorical Grants Fund (231), to support ongoing wildfire mitigation, Firewise

education, and forest restoration programs and projects.

This resolution appropriates Four Hundred Ninety Seven Thousand Six Hundred Fifty Dollars (\$497,650) in hazardous fuels mitigation funding as a pass-thru grant from the State of Alaska, Department of Natural Resources, under the 2009 American Recovery and Reinvestment Act, to the Anchorage Fire Department, State Categorical Grants Fund (231), to support ongoing wildfire mitigation, Firewise education, and forest restoration programs and projects.

The award provides additional grant funding to continue the Municipality's multi-year program to mitigate the wildfire risks associated with spruce bark beetle infestations; regenerate forests in the most severely impacted areas; restore the ecological diversity and vitality of the Municipality's urban forests; and promote Firewise education. In addition to providing substantial funding to secure contractual services, a portion of the award is set aside to fund direct personnel expenditures associated with maintaining the department's current Wildfire Mitigation Office.

The grant period runs from October 7, 2009 through March 30, 2012. No local matching funds are required.
