A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY PROCLAIMING APRIL 2010 AS SEXUAL ASSAULT AWARENESS MONTH AND ENCOURAGING THE CITIZENS OF ANCHORAGE TO WORK TOGETHER TO ELIMINATE SEXUAL ASSAULT CRIMES IN OUR COMMUNITY.

WHEREAS, in the United States, a woman is raped every 45 seconds, one in five adult women will be raped at some point in their life, and the rape rate in Alaska is more than twice the National average; and

WHEREAS, in the United States, one in four female children and one in six male children will be sexually assaulted before they are 18 years old, and Alaska has six times the National average of reported child sexual assaults; and
