As a Certified Local Government (CLG), the Municipality of Anchorage is eligible to apply for Historic Preservation Fund Certified Local Government 60/40 matching grants. As the Municipality's certified local government review body, the Anchorage Historic Preservation Commission wishes to apply for a CLG grant to develop a

local Adopt-A-Historic Property program.

The amount of the grant is \$19,895.00, with a \$13,064.00 local match. The cash contribution by the Municipality is \$3,200.00, which will be appropriated from the Municipality's Historic Preservation Fund. As of April 9, 2010, this fund has a balance of \$186,471.31. The remainder of the local match requirement will be met through professional services contributed by members of the Anchorage Historic Preservation Commission.

Anchorage Ordinance 2006-175 charges the Commission to "Develop and participate in public information, educational and interpretive programs and activities to increase public awareness of the value of historic preservation." The Adopt-A-Historic Property (AHP) Program falls within this charge to the Commission.

The goal of the AHP program is to increase public awareness of the value of historic preservation by educating the community and local historic property owners on methods of maintaining and rehabilitating historic resources and by recognizing local examples of excellence in the preservation of historic buildings, structures, and sites.

Increased public awareness of the value of historic preservation and educating historic property owners on maintaining and rehabilitating historic resources are essential to preserving the cultural heritage of Anchorage.

A resolution of support for the Certified Local Government grant application from the local governing body is a requirement of the application process.
