Subject: A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING FIFTY-SIX THOUSAND THREE HUNDRED FORTY-THREE DOLLARS (\$56,343) FROM THE STATE OF ALASKA, DEPARTMENT OF HEALTH AND SOCIAL SERVICES TO THE STATE DIRECT/FEDERAL PASS-THRU GRANTS FUND (231) FOR THE AGING AND DISABILITY RESOURCE CENTER IN THE DEPARTMENT OF

HEALTH AND HUMAN SERVICES.

On September 29, 2009, AR 2009-214 was approved by the Municipal Assembly appropriating \$106,280. The Department of Health and Human Services (DHHS) received \$56,343 in supplemental funds from the Alaska Department of Health and Social Services for a total of \$162,623. This appropriation will provide the funding necessary to provide Aging and Disability Resource Center services to older Alaskans and persons with disabilities in the DHHS. The period of this grant is from July 1, 2009 through June 30, 2010.

In 2003, the Administration on Aging (AOA) and the Center for Medicare and Medicaid Services (CMS) launched the Aging and Disability Resource Center (ADRC) initiative. This nationwide effort streamlines access to long-term care and complements other long-term care system change activities designed to enhance access to community living. ADRCs are also a part of the President's Long-Term Care Re-balancing Initiative and New Freedom Initiative. As of February 2008, there were over 140 Aging and Disability Resource Center pilot sites operating in 43 states and territories serving 30% of the population.

The goal of the Municipality of Anchorage (MOA), ADRC is to serve as an integrated point of entry into the long-term care system.
