The Municipality of Anchorage has received a grant from the State of Alaska, Department of Transportation & Public Facilities for a Drug Recognition Expert Training Conference program. This grant will be used for six drug recognition expert trained, sworn officers to attend the 16th Annual International Association of the Chiefs of Police Drug Recognition Expert Training Conference during the period July 21, 2010 through July 25, 2010.

This grant will be used to reimburse travel and training costs related to the Drug Recognition Expert Training Conference to be held in Pittsburg, Pennsylvania. This training will allow six officers to maintain Drug Recognition Expert Certification. With this certification, these officers will be able to obtain warrants for chemical blood testing in traffic stops where no signs of alcohol are present. Through increased awareness and enforcement of impaired driving violations, the citizens of Anchorage will experience safer roads and reduced traffic injuries.

A special condition of this grant is that the department provides matching funds. The total projected Municipal cost is \$10,111, which has been budgeted in the 2010 Police Department Operating Budget. This grant began June 15, 2010 and will end on September 30, 2010.
