Subject: A RESOLUTION APPROPRIATING ONE HUNDRED SEVEN THOUSAND FIVE HUNDRED DOLLARS (\$107,500) OF RETIREMENT CERTIFICATE OF PARTICIPATION (COP) DEBT SERVICE FUND (719) FUND BALANCE TO THE RETIREMENT CERTIFICATE OF PARTICIPATION (COP) DEBT SERVICE FUND (719) AS A CONTRIBUTION, AND APPROPRIATING SAID CONTRIBUTION TO THE ANCHORAGE FIRE DEPARTMENT, AREAWIDE GENERAL FUND (101) FOR PAYMENT OF A LABOR SETTLEMENT.

A former employee of the AFD filed suit against the Municipality, alleging constructive discharge and retaliation by his supervisors in the department for his alleged "whistle blowing" activities. Although the facts demonstrated that the Municipality had a good chance it would prevail at suit, there were a number of factors that posed significant problems for the Municipality. Accordingly, after much analysis by the legal department and the administration, a decision was made to settle the matter for a fraction of the potential liability. It was determined that, should the plaintiff prevail, the Municipality faced a potential liability for as much as six or more times the settlement amount. In reaching settlement, the parties agreed to keep the settlement provisions confidential, primarily to protect the Municipality's legal interests, although neither side admits any wrongdoing or liability. The settlement is a complete and final resolution of all claims, and the lawsuit has been dismissed.

This Assembly Resolution is necessary because the settlement agreement was reached only a few days before the scheduled start of trial. Given the short time frame between reaching settlement and the date set for trial, it was imperative that the payments to be made under the agreement were made quickly. The administration concluded that these payments should be the responsibility of the Fire Department, as the issues giving rise to the claims were primarily based within the department. Since this item was not budgeted and AFD cannot absorb the costs in its current operating budget without adversely impacting the department's ability to carry out its functions, the administration is requesting a supplemental appropriation to cover the cost of this settlement.
