This appropriation will provide the funding necessary to fund sub-awards to local non-profit social services agencies for services to the community. The Human Services Community Matching Grant (HSCMG) matching funds requirement is met using Municipal Operating funds, plus Community Development Block Grant -Public Service funds which were appropriated in a separate Assembly Action. The period of this grant is from July 1, 2010 through June 30, 2011.

The Municipal Assembly has approved (AM 396-2009) continuation of a contractual partnership with United Way of Anchorage to manage the HSCMG program, conduct a procurement process and distribute grant funding to non-profit agencies for essential health and human service programs. The current contract is from FY 2010 with three one-year option periods. All State of Alaska HSCMG funding plus the Municipal operating matching dollars will be provided to United Way of Anchorage, with up to 5% of the State funding provided for United Way of Anchorage administration.
