- 4. Administrative site plan review, required by AMC 21.50.500, has not been completed;
- 5. Approvals from the Municipal Health & Human Services and Building Safety Departments have been received; and

WHEREAS, protest by the Assembly is in order pending Municipal Clerk confirmation that outstanding items required for this location have been completed;

NOW, THEREFORE, THE ANCHORAGE ASSEMBLY RESOLVES:

- Section 1. The Anchorage Assembly hereby enters its PROTEST for a transfer of ownership of a Restaurant Eating Place Liquor License # 4517 and Restaurant Designation Permit until these conditions are met:
 - Successful completion of the administrative site plan review under AMC 21.50.500 is confirmed by the Municipal Clerk.
 - Approval from the Anchorage Fire Department is received and confirmed by the Municipal Clerk.
- Section 2. 
