A RESOLUTION APPROPRIATING A GRANT IN THE AMOUNT OF ONE HUNDRED FIVE THOUSAND SEVEN HUNDRED THIRTY-SEVEN DOLLARS (\$105,737) FROM STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION, TO STATE CATEGORICAL GRANTS (FUND 231) FOR A TRAFFIC SAFETY RESOURCE PROSECUTOR.

WHEREAS, the State of Alaska offered the Department of Law a grant for administration of the State of Alaska, Department of Transportation, Alaska Highway Safety Office (SOA DOT AHSO) Program; and

WHEREAS, the Department of Law agreed to administer the SOA DOT AHSO Program to meet the goals of both state and local interests, provided State funding is available; now therefore,

THE ANCHORAGE ASSEMBLY RESOLVES:


Section 1. The sum of ONE HUNDRED FIVE THOUSAND SEVEN HUNDRED THIRTY-SEVEN DOLLARS (\$105,737) is hereby appropriated from the State of Alaska, Department of Transportation, to State Categorical Grants Fund (231) for administration of the SOA DOT AHSO Program in the Department of Law.

Section 2. This resolution shall be effective immediately upon its passage and approval by the Assembly.

10 The Department of Law was approved to administer a grant for a Traffic Safety
11 Resource Prosecutor; the grant partially offsets the cost of the position. The
12 resolution appropriates the 2010 grant from State of Alaska, Department of
13 Transportation, Alaska Highway Safety Office (SOA DOT AHSO) to fund the
14 program.

16 The position requires a part-time municipal Traffic Safety Resource Prosecutor
17 (TSRP), funded by the grant, and a part-time DUI/Traffic Prosecutor, funded by
18 the city. An existing prosecutor position will be used to accommodate the
19 requirements of the grant.

21 The TSRP serves as the dedicated liaison among prosecutors, the police
22 department, State District Attorneys, AHSO, Alaska Injury Prevention Center,
23 public and private schools, and defense attorneys to provide information and
24 education to the motoring public, prevent impaired driving, and reduce DUI
25 collisions and fatalities.

27 The position requires arranging for training to educate all prosecutors and
28 police officers in testing relating to drug recognition evaluation, field sobriety
29 tests, and trial preparation. The TSRP also creates a DUI trial manual, and
30 assists prosecutors applying for scholarships and grants for national training
31 opportunities. In addition, the TSRP second-chair's difficult DUI trials and
32 other safety cases, and serves as a resource to evaluate DUI cases for
33 reduction or dismissal.
