The Municipality of Anchorage has been awarded a grant from the Department of Health and Human Services, Health Resources and Services Administration, in the amount of \$179,990 for the purchase of Automated External Defibrillators (AED). The awarded grant funding is intended to enable the purchase of approximately 100 additional AED's for deployment to the uniformed patrol division. Appropriation of grant and required local matching funds is requested to the Federal Grants Fund (241).

Originally funded in FY2009 and subject to the continued availability of funds and satisfactory progress of the project, this program has been recommended for future support in the amount of \$179,990 in FY 2011, the final of three project years.

A special condition of this grant is that the department contribute funds to support associated indirect grant costs. The total projected municipal cost is \$7,694 which is funded through a 2010 operating contribution from the Anchorage Metropolitan Police Service Area Fund (151). This grant project period began on September 1, 2009 and will end on August 31, 2012.
