**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY TO NAME
THE ANCHORAGE MUSEUM AT RASMUSON CENTER'S FOURTH FLOOR
GALLERY.**

WHEREAS, Anchorage Municipal Code (AMC) 3.97 governs a means of naming municipally owned buildings as well as other facilities and public places; and

WHEREAS, the Anchorage Assembly appointed a Citizen Naming Panel, as set out in AMC 3.97, to consider naming the Fourth Floor Gallery of the Anchorage Museum at Rasmuson Center; and

WHEREAS, the Anchorage Museum at Rasmuson Center completed construction of an 80,000 square foot expansion in the spring of 2010 on time and on budget; and

WHEREAS, the Anchorage Museum at Rasmuson Center's successful expansion project completion is due to the work, dedication, oversight of the Museum Building Committee, led by Committee Chairman Mr. Brian E. Davies; and

WHEREAS, Mr. Davies devoted over ten years of service to this project as committee chairman; and

WHEREAS, Mr. Davies is a longtime Alaskan, known and honored for his leadership roles in business and as a volunteer leader; and

WHEREAS, Mr. Davies personally made a generous contribution of \$50,000 in support of the museum expansion; and

WHEREAS, Mr. Davies has also made a bequest of his art collection to the museum; and


WHEREAS, after following the established policy and performing due diligence, the Citizen Naming Panel unanimously recommends that the Fourth Floor Gallery within the Anchorage Museum at Rasmuson Center be named: Brian E. Davies Chugach Gallery.

NOW, THEREFORE, the Anchorage Assembly resolves:

Section 1: To name the Fourth Floor Gallery at the Anchorage Museum at Rasmuson Center the:

BRIAN E. DAVIES CHUGACH GALLERY

Brian E. Davies Chugach Gallery


to honor and recognize Mr. Davies for his volunteer work over the years and his bequest of art collection to the Museum.

3.97.030 Procedures.

C. Final action by the assembly shall be no earlier than one year posthumously for naming of a building, facility, or park. In all naming or renaming, the assembly shall set the proposed resolution addressing the panel's recommendation for public hearing at least one month after introduction to ensure appropriate information dissemination to the public prior to final action by the assembly.

Report from Naming Panel for Anchorage Museum at Rasmuson Center's Fourth Floor Gallery:

Background per 3.97.020-30, Naming Policy, Procedures and Criteria;

Response to 3.97.025, Criteria. Regarding the proposed naming of the 4th Floor Gallery in the Anchorage Museum Expansion at the Rasmuson Center — Brian E. Davies Chugach Gallery

Honorary naming of a public place will:

1. *Demonstrate that the policy objectives under Section 3.97.020 have been considered (continuity, and historical/cultural/geographical naming) and will specify findings for an exception.*

The gallery to be named is a new interior space in the Anchorage Museum Expansion. This does not represent a name change. The new proposed name includes both the honoree, Brian E. Davies and the local geographic and cultural name of Chugach.

2. *Identify the individual's connection to the municipality if considering an outstanding local, state, national or international civic leader.*

As a volunteer, Brian E. Davies has Chairman of the Anchorage Museum Building Committee for over 10 years in delivering the \$106M Anchorage Museum Expansion on time and within budget. This is a major addition to the Anchorage community, including the Arctic Studies Center Smithsonian long-term exhibition and a merger with the Imaginarium, an interactive science discovery center. His leadership and persistence were a significant asset in making this dream a reality.

Mr. Davies personally made a generous contribution of \$50,000 in support of the Museum expansion and made a bequest of his art collection to the museum.

3. *Consider the historical significance of the person and the duration of residence in the municipality.*

Brian E. Davies is a longtime Alaska, known and honored for his leadership roles in business and as a volunteer leader. He has been a resident of Anchorage for over 30 years.

4. *Consider the history of the location in relation to the history of the present name if renaming an existing public place.*

The gallery to be named is a new space in the Anchorage Museum Expansion.

5. *Not change the name of a public place bearing an historic Anchorage family name.*

The gallery to be named is a new interior space in the Anchorage Museum Expansion.

6. *Not change historic names of designated landmarks listed on a state or National Register of Historic Places.*

The gallery to be named is a new interior space in the Anchorage Museum Expansion.

7. *Limit honorary naming to a one-time present use of an individual's name.*

There is no other honorary naming of spaces for Brian E. Davies.

8. *Support the preferred practice of honoring individual citizens through naming of internal areas integral to public spaces.*

The space to receive this honorary naming is a gallery on the fourth floor of the Museum.

9. *Renaming a public place, road or street should not be considered within 20 years of the previous naming.*

The gallery to be named is a new space in the Anchorage Museum Expansion.
