In this instance, the employees were part of a 2007 Fire Department reorganization started and completed under the Begich Administration. The employees alleged a broad range of violations and presented their claims in a variety of forums, including the Office of Equal Opportunity, the Anchorage Equal Rights Commission, the Department of Labor, and the United States Equal Employment Opportunity Commission.

Accordingly, a number of confidential grievances and other employment claims involving these non-represented employees of the Municipality, including claims that either had been scheduled for arbitration or for hearings, were evaluated by the Municipal Attorney's Office and the Employee Relations Department. These evaluations resulted in negotiated settlements that were determined to be significantly less than the risk of loss, had these claims proceeded without settlement. Additionally, in some of these matters, settlement of these claims helped preserve and enhance stability in the workplace and allowed the administrative function to proceed more efficiently.
