33 34 35 The Municipal Department of Health and Human Services (DHHS) has received a grant from the US Department of Health and Human Services, Health Resources and Services Administration for a "Health Care and Other Facilities" grant to cover facility repairs and renovations. The grant period is September 1, 2010 through August 31, 2011.

THE DEPARTMENT OF HEALTH AND HUMAN SERVICES.

The DHHS facility was first constructed in 1960 as a three-story hospital and later expanded to five floors. It currently houses the majority of the DHHS department services and serves Anchorage as a major public health clinic.

The existing mechanical systems in this building are reaching the end of their design life expectancy, causing heating and ventilation system deficiencies, water line failures, and other safety issues. Although there is not sufficient funding to address all of these issues, these funds will be used for refurbishing the steam boiler system, replacement of some of the severely worn carpeting, and associated non-friable asbestos abatement in the building.
