The attached Resolution appropriates a Three Hundred Eighteen Thousand Eight Hundred Forty-Eight Dollar (\$318,848) contribution from CBERRRSA Fund (Fund 119) approved in the BP2010 General Government Operating Budget to the CBERRRSA Capital Improvement Project Fund (Fund 419) for road and drainage capital improvement projects within the service area. On October 1, 1991 the voters approved a mill levy not to exceed one mill to fund the CBERRRSA Capital Improvement Project Fund. The revised total for the CBERRSA Capital Improvement Program approved in the BP2010 Operating Budget is Three Million Three Hundred Sixteen Thousand Nine Hundred Forty-Eight Dollars (\$3,316,948), of which Three Hundred Eighteen Thousand Eight Hundred Forty-Eight Dollars (\$318,848) has not been appropriated to the CBERRRSA Capital Improvement Fund (Fund 419). This figure represents the BP2010 First Quarter Budget Revision adjusted for the final approved mill rate and assessed valuation.

As the mill levy for CBERRRSA is collected, that portion designated for the Capital Improvement Program is transferred as a contribution to the CBERRRSA Capital Improvement Project Fund (Fund 419). Transfers from the CBERRRSA Fund (Fund 119) at no time shall exceed the pro-rata share of the collected Mill Levy designated for the CBERRRSA Capital Improvement Project.

The CBERRRSA Board is aware of this appropriation and recommends that the Assembly approve it.
