AN ORDINANCE SETTING THE RATES OF TAX LEVY, APPROVING THE AMOUNT OF MUNICIPAL PROPERTY TAX, AND LEVYING TAXES FOR ALL SERVICE AREAS OF THE MUNICIPALITY OF ANCHORAGE GENERAL GOVERNMENT FOR FISCAL YEAR 2011.

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1. The Assembly hereby fixes the rates of tax levy for all service areas of the Municipality of Anchorage general government for fiscal year 2011. The Anchorage Assembly levies these taxes upon the full value of all assessed taxable real and personal property as follows:

APPROVING THE AMOUNT OF MUNICIPAL PROPERTY TAX. 4 AND LEVYING TAXES FOR ALL SERVICE AREAS OF THE 5 MUNICIPALITY OF ANCHORAGE GENERAL GOVERNMENT FOR 6 7 FISCAL YEAR 2011 8 This memorandum transmits the ordinance to establish the 2011 tax rates and tax 9 levies for all service areas of the Municipality of Anchorage general government. 10 11 12 The tax rates and tax levies shown in AO 2011-41 are those required to support the revised 2011 General Government Operating Budget as proposed in the 13 Administration's first quarter budget revisions and presented in Assembly 14 15 Resolution 2011-73. 16 On average the mill levy is slightly higher (0.13) than the 2010 average mill rate. 17 18 This translates into a property tax increase of \$13.00 annually per \$100,000 of assessed valuation. 19 20 THE ADMINISTRATION RECOMMENDS APPROVAL OF THE ORDINANCE 21 SETTING THE RATES OF TAX LEVY, APPROVING THE AMOUNT OF 22 MUNICIPAL PROPERTY TAX.
