AN ORDINANCE ADOPTING AND APPROPRIATING FUNDS FOR THE 2012 OPERATING AND CAPITAL BUDGET OF ANCHORAGE COMMUNITY DEVELOPMENT AUTHORITY

WHEREAS, the Anchorage Assembly approved Assembly Ordinance 2004-181(S-1) as amended on January 18, 2005 establishing the Anchorage Community Development Authority (ACDA); and

WHEREAS, ACDA is an instrument of the Municipality of Anchorage, but exists independently of and separate from the Municipality; and

WHEREAS, the 2012 operating and capital budgets for ACDA have been reviewed and approved by the Anchorage Community Development Authority Board; now, therefore,

THE ANCHORAGE ASSEMBLY ORDAINS:


Section 1. The fiscal year 2012 Operating and Capital Improvement Budgets of the Anchorage Community Development Authority are hereby adopted.

Section 2. The 2012 Operating Budget appropriation for ACDA is \$9,798,061.


Section 3. The 2012 Capital Improvement Budget appropriation for ACDA is \$1,675,400.
