WHEREAS, the licensee has made an application with the Alcoholic Beverage Control (ABC) Board for renewal of Beverage Dispensary Liquor License #4157, to be used for Rumrunner's Old Towne Bar & Grill, located at 415 E. Street Anchorage, Alaska; and
