The period of this grant is from July 13 14 1, 2011 through June 30, 2012. 15 The Department of Health and Human Services (DHHS) operates the Child Care 16 Licensing Program (CCL) which has been responsible for licensing child care centers 17 since 1988. On September 23, 2004 the role of the unit was expanded to full child 18 care home licensing responsibility. CCL is fully responsible for issuing licenses and 19 enforcement. 20 21 In the previous year, the CCL served 117 licensed child care centers, which offer 22 Anchorage 8,097 spaces for child care. In serving child care homes, 169 were 23 assisted with 1,243 spaces for child care.
