WHEREAS, Frozen Wings, Inc. has made an application with the Alcoholic Beverage Control (ABC) Board and has paid the required fee for a Transfer of Location of a Beverage Dispensary Liquor License #398 and Restaurant Designation Permit, to be used for Buffalo Wild Wings, located at 3400 C Street, Anchorage, Alaska; and

WHEREAS, the Assembly must enter any protest to the ABC Board within 60 days following receipt of the application; and

WHEREAS, the Anchorage Municipal Clerk received a copy of this application on September 12, 2011 and has determined that the last day for the Assembly to file a protest is November 11, 2011 and

WHEREAS, the Assembly Meeting on November 8, 2011 is the last scheduled regular meeting of the Anchorage Assembly prior to the expiration of the protest period; and

WHEREAS, the Municipal Clerk reports the following status concerning this location:

1. No ABC Board violations and/or incidents that would lead to an ABC Board violation;
2. No taxes owing to the Municipality of Anchorage;
3. Approval from the Building Safety Department **has been received**;
4. Conditional Use Permit required by AMC 21.50.160; **has been approved**;
5. Approvals from the Anchorage Fire Department and Municipal Health and Human Services **have not** been received; and
