The capital assistance grant, once fully executed, provides \$750,000 in FTA grant funds and requires a local match of \$187,500. The match will be provided from previously appropriated and available legislative grants and approved 2011 State Legislative funding for Public Transportation. This capital assistance grant funds the purchase of a fare collection system and construction and acquisition of mechanical and support equipment and other improvements to transit assets. The contribution of \$15,000 from the Public Transportation Department's 2011 General Fund Operating Budget will provide for the support of Municipal Central Service Agencies to this project.
