10 **THE ANCHORAGE ASSEMBLY RESOLVES:**

12 Section 1. That the sum of NINE THOUSAND FIVE HUNDRED SEVEN DOLLARS  
13 (\$9,507) is appropriated as a grant from the Bureau of Justice, Office of Justice Programs, U.S.  
14 Department of Justice to the Federal Grants Fund (241), Anchorage Police Department, for the  
15 Bullet Proof Vest Partnership Program.



17 Section 2. That the sum of TWO HUNDRED NINE DOLLARS (\$209) is appropriated as a  
18 contribution from the Anchorage Metropolitan Police Service Area Fund (151), 2011 Anchorage  
19 Police Department Operating Budget as a contribution to the Federal Grants Fund (241) for the  
20 Bullet Proof Vest Partnership Program.

**Subject:** A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THE SUM OF NINE THOUSAND FIVE HUNDRED SEVEN DOLLARS (\$9,507) FROM THE BUREAU OF JUSTICE, OFFICE OF JUSTICE PROGRAMS, U.S. DEPARTMENT OF JUSTICE AND TWO HUNDRED NINE DOLLARS (\$209) FROM THE 2011 ANCHORAGE POLICE DEPARTMENT OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE FEDERAL GRANTS FUND (241) ANCHORAGE POLICE DEPARTMENT FOR THE BULLET PROOF VEST PARTNERSHIP PROGRAM.

October 25, 2004, Public Law 108-372 reauthorized the Bulletproof Vest Partnership Grant Act of 2000 and extended the program funding through 2012. The program provides for up to 50% reimbursement of department costs for the purchase of replacement ballistic armor for its sworn officer force.

The Municipality of Anchorage, Anchorage Police Department, has received a grant from the Bureau of Justice Assistance, Office of Justice Programs, U.S. Department of Justice to offset the cost of supplying bullet proof vests to sworn patrol officers in the amount of \$9,507.

A special requirement of this grant is that the department provide a contribution to cover unallowable indirect intergovernmental charges. The total anticipated department cost is \$209. The performance period of this grant is October 1, 2011 to September 30, 2013.
