This temporary non-objection shall not be used to bind the Assembly to any future action on the transfer of this liquor license, including without limitation, final action by the Assembly on the application for transfer of location and ownership of Beverage Dispensary Liquor License #2988, with the Restaurant Designation Permit, to F. Scott & Ernest, LLC, DBA Little Italy Restaurant, and conditional use application 2012-001.

Subject: AR 2011-355 — A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY STATING ITS TEMPORARY NON-OBJECTION TO TRANSFER OF LOCATION AND OWNERSHIP OF BEVERAGE DISPENSARY LIQUOR LICENSE #2988, WITH THE RESTAURANT DESIGNATION PERMIT, TO LITTLE ITALY RESTAURANTE AND TO ALLOW ALCOHOLIC BEVERAGE LICENSE USE TEMPORARILY AT THE LOCATION, UNTIL FINAL ACTION BY THE ASSEMBLY ON APPLICATION 2012-001 FOR CONDITIONAL USE.

The purpose of this Assembly Resolution is to issue a temporary non-objection and allow alcoholic beverage license use temporarily, until the matter comes before the Assembly in 2012. As noted by the Municipal Clerk, the owners have successfully completed and satisfied all of the routine requirements, aside from the new conditional use permit.

Little Italy Restaurante, 2300 E. 88th Street, Anchorage, Alaska 99507, is located in an I-1 light industrial use area. Little Italy Restaurante has been serving beer and wine under prior permitting practice, predating the 2007 code change that now allows administrative site plan review, in lieu of formal conditional use permitting by the Assembly. The municipal licensing clerk reports that prior to 2007, the special zoning exception at this location was simply carried forward from a prior business. A copy of AM 422-79, the special zoning exception issued on May 15, 1979 to a predecessor business at the same address, has been provided by the municipal licensing clerk and attached for ease of reference.

Because of the 2007 code changes, all current restaurant or eating place alcoholic beverage license use is deemed to be under administrative site plan review, and a new conditional use permit is required. *Little Italy Restaurante* has made appropriate application for a transfer of location and ownership of Beverage Dispensary Liquor License #2988, with the Restaurant Designation Permit. The Municipal Clerk reports: 1) No ABC Board violations and/or incidents that would lead to an ABC Board violation; 2) No taxes owing to the Municipality; 3) Receipt of Anchorage Fire Department Approval; and timely receipt of approvals from Municipal Health & Human Services and Building Safety Departments. Action on the conditional use permit application is anticipated to come before the Assembly on January 17, 2012.

 Approval of this temporary non-objection will allow *Little Italy Restaurante* to proceed with transfer of ownership and location of ABC Board beverage dispensary license No. 2988 at a location previously recognized for alcoholic beverage use by the Assembly, without routine delay and forbearance during the upcoming holidays.

The proposed establishment is located in a I-l use district. The Alcoholic Beverage Control Board may pursuant to Alaska State Statute 04.10.230 deny a request for a liquor license application based on the disapproval of a special zoning exception, which is required by Section 21.45.170 of the Anchorage Municipal Code. Therefore, the Director of the Alcoholic Beverage Control Board has requested that the Assembly take two actions:

- 1. to grant or deny the special zoning exception
- to issue an approval or disapproval of the issuance of the liquor license and waive the 30 day protest period.

There is an estimated population of 202,101 residing within the Municipality of Anchorago and there are 110 other like licenses. Notices were mailed to the 95 property owners within 500 feet of the premises on April 26, 1979 and an 2d appeared in the newspaper on May 6, 1979.

The Department of Health and Environmental Protection has inspected the facility and it complies with Environmental Health Codes. The Municipal Fire Department has approved of the operation of this license. There are no taxes owing. There are no utilities owing.

The Municipal Clerk will notify the Alcoholic Beverage Control Board of the Assembly's action in this matter.




